

Obvious error is an incorrect or incomplete execution of client orders by the Dealer. It may be opening or closing the Client's position at wrong price or at a price that is significantly different from the price to be specified in the order of Customer. An obvious mistake is the dealer non-functioning in a situation favorable for order execution for the price specified or market prices incorrect definition at the desired time interval.
